## **CONDITIONS:**

I hereby accept and agree to the following Terms and Conditions pursuant to the hire of the Labrador Community Bus from Labrador Sports Club Inc. (herein called LSC Inc.):

I also warrant the information provided to LSC Inc to be true and correct.

1. In this agreement, the Bus means the described vehicle, including all fixed components and other removable components such as tyres, spare wheel, tools, accessories, vehicle log book, owner manual.
2. I acknowledge that the vehicle, when delivered to me, was in good condition and sound working order.
3. I undertake to return the bus to the Gold Coast Hockey Centre no later than the return date and time shown above, or before the return date if LSC Inc. so requests.
4. I agree to refill the bus with fuel at a fuel supplier nearby to the Gold Coast Hockey Centre on return and other costs specified in this agreement. I agree that I am liable for any costs resulting from my failure to fill the bus with diesel fuel only.
5. I accept that I am liable for, and will pay forthwith, all parking fines, tolls, penalties and road traffic infringements while the vehicle is in my possession, regardless of whether I am the driver or not.
6. I agree to meet all costs and expenses, including legal fees, incurred by LSC Inc. as a result of any breach by me of this Agreement or events rising from use of this bus.
7. In abiding by the terms and conditions of this hire agreement I understand that the bus will be insured against any loss or damage to the bus resulting from collision. However, the insurance will not cover, and I will be directly liable for, the full recovery of costs of all damage arising from any accident if:
  - a. The bus is driven by any person who is unlicensed or under the age of 21.
  - b. Any person under the influence of intoxicating liquor, illicit drugs or medication known to affect judgement, is in control of the bus.
  - c. The bus is driven by any person found to have a blood alcohol level in excess of the State legal limit, or when the driver refuses to submit as directed to a lawful police breath analysis or blood alcohol test.
  - d. The ignition keys are left in the bus or the bus is left unlocked while unattended.
  - e. Loss or damage to the bus was a result of my negligence or abuse.

8. Following any accident or loss or damage involving the bus, I undertake to advise LSC Inc's representative within 24 hours of the accident and or damage.
9. **I agree that an excess charge can be levied against my account for \$1,000 which is the charge in the event the bus has any accident or damage while in my care, custody or control and will be collected by LSC Inc. or its insurance company.**
10. I will not permit the bus to participate in any test, race, promotion or other contest, or be engaged in towing or pushing anything (LSC Inc. hired trailer excepted).
11. I undertake to drive the bus within the distance stated above from the Gold Coast Hockey Centre.
